- F. <u>2011-2012 Budget Overview Districtwide</u> Superintendent Paul Freeman indicated that this is the first presentation to kick off the 2011-12 budget season. Dr. Freeman presented the administrative portion of the 2011-12 budget. Included in the presentation were the following items: GPS mission, GPS goals for 2010-11, budget priorities, a district-wide overview, four year comparison of the budget figures, what is driving the 4.34 increase, staffing proposals and reductions and efficiencies.
- G. <u>2011-2012 Budget Overview Special Education</u> Director of Special Education & Services Madeline Illinger presented the Special Education portion of the 2011-12 budget proposal. Including in her presentation were the following items: Special Education mission, special education past/current enrollment comparisons and notable increases/decreases to the budget.
- H. <u>Letters to Senator Andrew Maynard and State Representative Steve Mikutel</u> The Superintendent encouraged the Board to accept a letter written to our local state senator and representative advising them of the importance of the ECS grant to Griswold Public Schools and requesting their support of fully funding the ECS grant. #### **ADMINISTRATORS REPORT**

A. 2011-2011 Out of District Summary Report – Director of Special Education & Services Madeline Illinger presented an out-of-district summary report to the Board. The report detailed the number of students placed out of district, tuition rates, transportation costs, whether students were placed by Griswold Public Schools or outside agencies, tuition costs for each student and excess cost based on a conservative 50% reimbursement rate.

B. Individuals w/Disabilities Education Act Fiscal Compliance Report – Director of Special Education & Services Madeline Illinger reported that the federal government is requiring the state of CT to conduct a fiscal desk audit on the IDEA grant and they are starting with two regions in the state. EASTCONN, our RESC, is one of the two regions to be audited. The desk audit is being conducted to ensure that IDEA grant monies are being used correctly. Mrs. Illinger met with EASTCONN and area special education directors recently. She reported that Shipman and Goodwin drafted procedures addressing this desk audit. Mrs. Illinger took the procedures and made a few adjustments and would like to use these procedures and make them a part of Griswold's special education procedural manual. The Superintendent reported that no action is necessary from the BOE but it should be noted in the minutes that this document was presented to the Board.

Associate Principal Matthew Peel wanted to share a lesson he learned in December following the accident that claimed the lives of four GHS students and critically injured a fifth student. Mr. Peel reported that Dr. Frizzell knew right from the very beginning to take a stance, to take charge, to put people in positions to make good decisions. He worked closely with Dr. Freeman and the administration. He directed faculty, staff and students during the weeks following the accident. He became the father of the entire school during this time. Mr. Peel noted that there is no award that we can give him but acknowledge what he did in this time of crisis. Our school would not have gotten through this without Dr. Frizzell.

Dr. Freeman added that nobody could have handled this situation better than Dr. Frizzell did. He handled it with grace and with strength. Thank you Dr. Frizzell.
