- This month's projection shows a significant decrease in expenses, as was expected. This is primarily due to transfer of salary/benefit expenses from the general fund to the CRF grant.
The ESSER grant still remains fully intact. As was noted before, this grant is available for two years. Although we have many expenses that can be covered with ESSER, the goal has been to cover as many of them as possible with the

Transportation lines reflect reductions due to shutdowns - the impact is primarily for regular education buses
Special education tuition for all current students have been received and encumbered.

- Regular education tuition invoices have been received from all but one town This month's projection includes an estimate from that town based on last year's total plus a $2 \%$ increase

Overall, we are in a very strong financial position at this time. The hybrid model, coupled with longer periods of full shutdown, result in reduced expenses in many areas
