Overview and Description

- Provide access for children to quality programs, minimize developmental delays
 in young children, options for families, strengthen families through parent
 involvement and education, reduce costs for special education by addressing
 needs before age 5, assure children with disabilities transition to K, coordination
 and cooperation among programs and prevent duplication of services
- Provide funds for children ages 3 5 and access to education and care in the following settings: profit, not-for-profit private programs, public prek programs, HS programs, faith-based programs and state-funded day care programs.
 Programs must be NAEYC Accredited or eligible for NAEYC accreditation.
- Monitoring Requirements: collaboration with community programs and services and coordination of resources, parent involvement, education, outreach, record keeping, pre-literacy and family literacy practices, referrals, nutrition services, admission policies, transition practices, staff PD, sliding scale fees, annual evaluation of program
- Reports: monthly, and additional as requested
- Enrollment: 60% at or below 75% of the state median income
- Review of PD requirements: 15 hours of professional learning annually: 2 focused on early childhood development, 1 in effectively including and caring for children with learning differences (including those with disabilities and dual-language learners), new staff must have or obtain specific training in pre-literacy skill development and in racial and ethnic diversity within the first year of hiring.
